**Professor Stéphane Goutte** is a university full professor with two doctoral degrees (PhDs), one in mathematics and another in economics. He earned his “Habilitation à Diriger des Recherches” (HDR) in 2017 from the University of Paris Dauphine. He holds professor positions at UVSQ University Paris-Saclay and the University of Luxembourg. He is also an affiliated professor at the École Supérieure de Commerce de Paris. Stéphane teaches mathematics and related subjects at both the master's and bachelor's levels. He serves as an associate editor for the International Review of Financial Analysis (IRFA), Energy Policy (JEPO), deputy editor of the Journal of International Financial Markets, Institutions and Money (JIFMIM), and is a member of the editorial board of the European Management Review (EMR).

His research interests lie in the field of mathematical finance and econometrics applied to energy and commodities. Stéphane has authored over forty research articles published in international journals.

**Professor Thomas Péran** is Associate Professor at Lusail University in Qatar, where he directs the program of Paris 1 Panthéon-Sorbonne University. He also serves as the Executive Director of the ROLACC Center in Geneva (the Anti-Corruption Center of the United Nations Special Advocate), and he is a former Secretary-General of the International Association of Anti-Corruption Authorities (IAACA). With a Doctorate (PhD) in Public Law from Sorbonne University and previous experience as an inspector in a major French bank, he also holds many international certifications (ISO37001 Lead Implementer/anti-bribery management systems, Artificial Intelligence Expert and Blockchain Expert, etc.).

Dr. Thomas Péran is the author of the reference book "Bank Management" (8th edition) published by Dunod and a reference work on constitutional law with L'Harmattan Editions. He teaches public law, mainly constitutional law and human rights, as well as topics related to good governance, including compliance and anti-corruption measures.

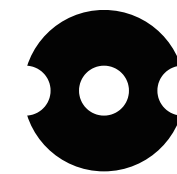
